



# End-User License Agreement ("Agreement")

Last updated: (August 10, 2017)

## Definitions

**Application:** (case insensitive) Is the software (a computer program including it's source codes, compilers and interpreters) named under trademark "CheqMate" with it's version suffixes.

**You:** (case insensitive) is the party using the Application for it's intended purposes.

**The Company:** (case sensitive) is the sole owner of the Application, it's source codes and all it's intellectual properties. Prezire Software Solutions represents The Company.

Please read this End-User License Agreement ("Agreement") carefully. By downloading, installing or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement.

If you do not agree to the terms of this Agreement, do not download, install or use the Application.

## License

The Company grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Application solely for your inter-organizational, personal, and non-commercial purposes strictly in accordance with the terms of this Agreement.

Product license provides only for a period of 365 days and another seven (7) days grace period after expiration. You need to renew the product license before expiration by paying an amount of LKR 1,250 (one thousand two hundred fifty) as indicated on official invoice. An official invoice will be email and post minimum thirty (30) days before the expiration date.

## Restrictions

You agree not to, and you will not permit others to:

- a) License, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the Application or make the Application available to any third party.
- b) Change the source codes, or reverse engineering of the Application
- c) You are only allowed to install this Application in a single PC (personal computer or server) at a one physical location only.
- d) Only five (5) installations are granted from a single license (product license) per year. If you exceeded this limitation you will have to wait till the annual renewal cycle is completed.
- e) Annual installation limit restoration (see above clause d) valid only if your product license is valid and not expired. If your annual product license is expired, installation limit will restore upon renewal of the license.

## Modifications to Application

The Company reserves the right to modify, suspend or discontinue, temporarily or permanently, the Application or any service to which it connects, with or without notice and without liability to you.

## Support Service

Help and support service will be only provided through our online support forum, online chat service and TeamViewer™ / Ammy™ / Aero™ Admin only. No visited service is provided.

To obtain support services in any of above mentioned methods, you should have a valid, none expired product license.

### **Product Training**

Product training materials are provided at the <http://cheqmatepro.com> URL address. No visited FREE personal training provides for the Application. PAID personal training sessions can be arranged upon contacting The Company.

### **Term and Termination**

This Agreement shall remain in effect until terminated by you or The Company.

The Company may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice.

This Agreement will terminate immediately, without prior notice from The Company, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your mobile device or from your desktop / laptop.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application from your mobile device or from your desktop / laptop.

### **Reversibility**

If any provision of this Agreement is held to be unenforceable or invalid, such provision will be changed and interpreted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the remaining provisions will continue in full force and effect.

### **Amendments to this Agreement**
